



GROUP EVENT CONTRACT

1. Group Event Fees are:

- a. Group Size 2-12 persons: **\$350**
- b. Group Size 13-24 persons: **\$450**
- c. Group Size 25-36 persons: **\$550**
- d. Group Size 37+ persons: **\$700**

2. The event fee reserves the green and rinks for **2 hours** and includes lawn bowling equipment and club member volunteers to instruct and oversee your event.

3. Your event will be booked once a **\$100 deposit** is paid and a **signed Group Event Agreement** (opposite side) is received. The **balance is due 7 days prior** to the event.

4. Public restroom facilities are available on the backside, lower level of Bartolotta's Lake Park Bistro.

5. Picnic tables, benches and chairs are available for use by your group. If these are not sufficient to meet your needs, you may supply additional tables and chairs which must be removed within 1 hour of the event end time.

6. Food and Beverage: If your group desires food and/or beverage at your event, you must supply your own. We are unable to offer arrangements with vendors or caterers. Many groups choose to have their event catered by Bartolotta's Lake Park Bistro, conveniently located next to the greens

7. Electricity: A limited number of electrical outlets are located inside of the clubhouse.

8. Footwear: **Shoes with heels of any size are not allowed** as they damage the grass playing surface. Guests must wear soft, flat-soled shoes on the greens. Barefoot is also an option.

9. Clothing and Sun: Dress for comfort, keeping in mind that delivering a lawn bowl requires you to bend at the knees and to take a short lunge-type step. Sunscreen, hats, visors, sunglasses are strongly encouraged.

11. Cancellation & Refunds: If your event is cancelled due to inclement weather or as determined by Milwaukee Lawn Bowling, then the entire amount paid will be refunded. If your event is cancelled for any other reason greater than 24 hours before start time, then the amount paid minus the \$100 deposit will be refunded. If your group event is cancelled for any other reason less than 24 hours before start time, there will be no refund.

12. Milwaukee Lawn Bowling reserves the right to ask guests to leave the premises for disruptive behavior or destruction of the clubhouse, greens, or property.

13. All guests agree to indemnify, defend, and hold harmless MLPLBA from and against all loss or expense including costs and reasonable attorney's fees and/or liability for damages for personal injury and property damage to the extent caused by any negligent or willful act or omission of guests.
